It is recommended that 3 inch reels be combined onto larger reels as there is an increased chance of damaging the original film if reels are left uncombined. Once spliced together, the film only needs to be fed into a projector once, which is when damage is most likely to occur. Storage is also easier with fewer numbers of small reels. If you prefer not to combine reels, there is a service charge of \$2.00 per 3 inch reel.
